

PARTNERSHIP AGREEMENT EXTENSION

WHEREAS, the following parties entered into a Partnership Agreement for the Establishment and Operation of the Escalante River Watershed Partnership (ERWP) to develop a collaborative and comprehensive approach to restore, protect and maintain a healthy riparian ecosystem in the Escalante River watershed in Garfield and Kane Counties, Utah (Partnership Agreement):

Boulder Community Foundation, dba Escalante River Basin Initiatives; Dennis Bramble; Conservation Legacy; Dixie National Forest, U.S. Forest Service (USFS); Escalante Canyon Outfitters; Escalante Outfitters; Four Corners School / Canyon Country Youth Corps; Glen Canyon National Recreation Area, National Park Service (NPS); Grand Canyon Trust; Grand Canyon Wildlands Council; Grand Staircase-Escalante National Monument (BLM); Grand Staircase-Escalante Partners; Great Old Broads for Wilderness; Natural Resources Conservation Service (NRCS); The Nature Conservancy; Partners for Fish & Wildlife, US Fish & Wildlife Service; Rim to Rim Restoration; Mike Scott; Craig "Sage" Sorenson; Tamarisk Coalition; U.S. Geological Survey; Utah Division of Water Quality; Utah Division of Wildlife Resources; Utah State University on behalf of the Utah Conservation Corps; John "Loch" Wade; Wild Utah Project; and American Packrafting Association.

WHEREAS, Article VII of the Partnership Agreement set the term of the agreement as five (5) years from the date of the first signature, unless terminated earlier by all parties. The date of first signature was June 23, 2011.

WHEREAS, the Partnership Agreement has not been terminated and the partnership's work has not been completed. The approved 10-year Action Plan outlines strategies and related actions until at least 2020. Monitoring and maintenance of the partnership's completed work will extend beyond 2020.

NOW, THEREFORE, the signatories of this document agree to extend the Partnership Agreement for an additional five (5) years, as follows:

Section 1. Term of Partnership Agreement Extended

The term of the ERWP Partnership Agreement is extended for an additional five (5) years from June 23, 2011, unless terminated earlier by all parties as per Article VIII of the Partnership Agreement. A copy of the Partnership Agreement is attached to this Partnership Agreement Extension and incorporated herein by reference.

Section 2. Partnership Agreement Remains in Full Force and Effect

Except for an extension of the term, the Partnership Agreement remains in full force and effect as it was written when the partners signed it between June 23, 2011 and June 9, 2015.

Section 3. Additional Partners

Individuals and organizations may join the ERWP at any time by signing the Partnership Agreement and this Partnership Agreement Extension, and indicating their intended roles and responsibilities in Article V of the Partnership Agreement.
