- Springs and seeps (Brooke Shakespeare, USFS)
 - o Groundwater dependent ecosystems (GDE)
 - 27 spring survey sites over 2 years
 - Informal analysis
 - 2014 springs close to or at surface with water, but don't turn into streams
 - lot of isolated wet spots on landscape
 - Water level recording -- 2 years data for Hall Creek
 - Looking for heterogeneity / variability of hydrologic response in watershed (reasons for recharge or not)
 - Topography / gradient flat or steep (can water pool)
 - Geology what's at surface, nature of rock (can affect or drive spring recharge)
- Q: What is source of Hall Creek water?
- A: Snowmelt driven, but spreads out over the year. Not necessarily spring-driven.
- Q: would introduction of beaver even out the peaks? What is historic data on beaver?
- A: Grundy documents first-hand experience regarding more water with beaver present.

- Science workshop (Joel Tuhy, TNC)
 - Following up on Melissa Masbruch's Hydrology 101 June presentation in Boulder, and great community interest expressed there
 - Held workshop in Deer Creek
 - What do we know?
 - What do we not know?
 - What information is not being collected?
 - o Federal agencies doing a lot of collecting information (USGS, GSENM)
 - Funding cuts has caused some data collection to stop
 - Explore a process to gather bits of information in one place so that all can have access to the same information re: reliable source of water
- · Discussion:
 - Encourage connection between private landowner and federal land managers to gather / collect relevant information
 - Some USGS gauging stations have been taken off-line (Deer Creek, Boulder)
 - Can ERWP raise \$\$ to bring them back on-line?
 - Adopt-a-gauge?
 - Estimate \$20,000/gauge/year?
 - USGS visits gauges ever 6 weeks to correlate profile and read gauge
 - Possibly could train FS employees to read gauges
 - Use citizen science to read gauges?

 - Grand Canyon NP has done citizen science

- Change in responsibility for private land restoration
 - Effective 2/1/15, Grand Staircase-Escalante Partners (GSEP) will be the hub for Russian olive removal on public and private lands
 - Boulder Community Alliance (BCA) will focus their energies on Boulder community issues
 - Most of RO removal in future is in Escalante area
 - Advantages:
 - Less confusing for grantors and donors / reduced competition for funds
 - Increased consistencies and efficiencies
 - Shared employee resources across public and private land efforts
 - Private landowner participation in RO removal will continue to be voluntary;
 ERWP has no authority to force landowners to cut RO

 - Herbicide safety and hands on training
 - ERWP staff and corps crew leaders offered one-on-one training, and saw tips and tricks.
 - Due to training, zero accidents in the field

 - Season totals: 378 acres, ~5 river miles (not including tributaries)
 - E. River, Death Hollow (GSENM): 22.64 acres, 1.03 river miles

 - E. River, Boulder Creek (GSENM): 23.48 acres, .75 river miles
 - Alvey Wash (GSENM): 158.65 acres
 - E. River, Harris Wash (GLCA): 54.81 acres, 1.46 river miles
 - Upper Boulder Creek/Nazar Draw (DNF): 46.53 acres
- 2014 Public Lands on-the-ground budget \$713,200
 - 47% is Walton Family Foundation
 - Funding sources (including WFF): 7 sources

 - 5 new rapid monitoring sites established

 - Boulder
 - Monitored every parcel ever treated
 - One small initial cut this year

 - DWR monitoring above Harris Wash
 - Finding dramatic decline in roundtail chub / virtually none left
 - Organizing sampling trip from Harris Wash downstream
 - · DWR, Glen Canyon NRA, BLM, FS
 - Looking at fishless sections to Lake Powell for reintroduction
 - o Calf Creek as potential native fish restoration site
 - Potential restoration steps:
 - Use piscicide for non-natives
 - Build barrier (downstream of campground on BLM land)
 - Reintroduce fish
 - · Conduct outreach near to campground
 - Discussion:
 - Community has difficulty with use of rotenone
 - Q: Will piscicide (chemical) go beyond Calf Creek into the Escalante River?
 - A: NO.
 - Q: Will rotenone kill all life under the rocks?
 - A: Rotenone application rates used currently are very minimal to get target species. Density and diversity of animals recovers fully within one year. One study shows that rotenone properly applied results in no greater harm than a big flood.
 - Q: Is rotenone harmful to humans?
 - A: A recently published peer-reviewed article concluding "no" for levels used in fish restoration will be shared with the partnership.
